INTRODUCTION

Valour Digital Asset Basket 10 (VDAB10) is an exchange-traded product tracking the price of the 10 largest Digital Assets based on the average monthly market capitalisation on the 15th calendar day of the month, for the two most recent months. The constituents are weighted by their current market capitalization, with a maximum weight of 30%. Available for purchase on regulated stock exchanges via any bank or broker. The product is a structured investment under Swedish law and traded on the Börse Frankfurt Zertifikate AG in Germany.

CALCULATING THE PRICE OF **VALOUR DIGITAL ASSET BASKET 10 (VDAB10)**



We calculate the arithmetic mean price from six major exchanges¹



Using market rates, we convert the dollar value of the index (USD) into the product currency (EUR)



We deduct an annual management fee daily on a pro rata basis



We apply the multiplier 0.1 to set the price of one certificate, making it an affordable unit price

1 The reference price is set using the average price of the underlying index (USD) from six most liquid exchanges. The exchanges used may vary depending on their trading volumes.
