Since its inception in 2009, the digital asset industry has surpassed a peak cumulative market capitalization of \$3tn, significantly outperforming other asset classes including, precious metals, real estate, equities, and debt securities. As a space defined by continuous innovation and ever-increasing real world applications, digital assets are revolutionizing existing industries and systems as we know it.

INDEX METHODOLOGY

Careful consideration has gone into the construction of the Valour Digital Asset Basket 10 ETP.

Aimed at providing investors with both a balanced and diverse coverage of the evolving digital asset space, the VDAB10 ETP has a maximum constituent weight of 30%, based on the average monthly market capitalization on the 15th calendar day of the month, for the two most recent months, with quarterly rebalancing. a constituent exceeds the maximum weight, its weight will be reduced to the maximum weight and the excess weight will be redistributed proportionally across all other index components. This process is repeated until no component has a weight exceeding the maximum weight. The selection of constituents and their target weights is rebalanced quarterly on the last business day of the month.

This weighting ensures that investors can gain a broad and trusted access to the largest and most innovative crypto assets shaping the future of the digital asset ecosystem.
