Objectives and investment policy

Objective: The Fund aims to grow your investment.

Policy: The Fund invests at least 70% of its assets in shares of companies based in, or closely associated with, the Asia Pacific region (excluding Japan).

The Fund invests in companies offering the potential to pay a regular income as well as having the potential for long term growth.

The Fund may invest in any emerging markets in the Asia Pacific region, in companies of any size or industry. Emerging markets are countries that are progressing toward becoming advanced, usually shown by some development in financial markets, the existence of some form of stock exchange and a regulatory body.

The Fund will not invest more than 50% of its assets in China A Shares.

The Fund's performance is compared against the value of the MSCI AC Asia Pacific ex Japan Index.

The Fund is actively managed meaning that the Fund's manager uses expertise to pick investments rather than tracking a benchmark. A majority of

the Fund's assets could be components of the benchmark. Investment of the Fund's assets is not constrained by the benchmark composition and the Fund's manager has complete discretion within the Fund's investment policy to invest in assets without regard to the benchmark.


The Fund may use derivatives with the aim of risk reduction or efficient management.

You can buy and sell shares in the Fund on any dealing day. A dealing day is generally defined as a day on which Irish banks and, if applicable, the relevant stock exchange(s) are open for business. Exceptions are noted on the FSI website. As long as we receive your instruction before 10 am (Irish time) on a dealing day, shares will be bought and sold at that day's price

The Fund will not pay any income out; instead any income will be reflected in the value of your shares.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within five years.

Risk and reward profile


