

# Key Investor Information

This document provides you with the key investor information about this Fund. It is not marketing material. ### Objective and investment policy

#### Objective

To seek to achieve income (money available to be paid out by the Fund) with the potential for capital growth (an increase in the value of the Fund) after all costs and charges have been taken, over the medium term (3 to 5 years).

There is no guarantee that the objective will be met over any time period and you may get back less than you invest.

#### Investment Policy

To invest at least 80% of its assets globally in equities (which includes company shares, investment trusts and Real Estate Investment Trusts, which are companies that aim to generate an income and/or profit from investing in property) and equity related securities (investments whose value is linked to the performance of the shares in one or more companies). The Fund may also invest in bonds (for example, loans to either a company or government that pay interest), money market instruments (for example, short term loans that pay interest), deposits and cash and indirectly in property. Exposure to these asset classes may be achieved by investing in investment trusts and other funds (including those managed by the Manager, the Investment Manager and their associates). The Fund will invest in line with the requirements of the Investment Manager's Climate Change Mitigation Policy (as further described in the Investment Strategy in the prospectus).

Investments will not be made in companies which derive material exposure to revenues from fossil fuels, pornography, tobacco, alcohol, gambling, high interest rate lending and certain types of armaments. Investment in government debt is limited to that issued by Canada, France, Germany, Italy, Japan, the UK and the US (commonly known as the "G7"). You should read this document before investing.

The Investment Manager's investment decisions will be based on an assessment of various factors including the potential for dividend growth and growth in cash flow and profits. The Investment Manager will seek to construct a portfolio of investments to deliver income but which may also grow in value over time.

The Investment Manager aims to construct a portfolio for the Fund that seeks to promote climate change mitigation through an investment process which assesses a company's alignment to, or commitment to align to net zero greenhouse gas emissions by 2050. The Investment Manager also assesses the corporate governance practices of companies in which the Fund may invest. The asset classes to which this investment process applies are set out in the Investment Manager's Climate Change Mitigation Policy on the Investment Manager's website at [www.taml.co.uk](http://www.taml.co.uk). It does not apply to other assets within the Fund.

#### Other features of the Fund:

- The Fund is actively managed. The Investment Manager uses its expertise to select investments for the Fund and has the discretion to invest in a range of investments as described above with no need to adhere to a particular benchmark.
- The Fund can invest across different geographic areas and industry sectors without limitation.
- Income from the Fund will be added to the value of your investment.
- Derivatives (whose value is linked to that of another investment, e.g company shares, currencies, etc) may be used to manage the risk profile of the Fund.
- You can buy and sell shares in the Fund on each business day.
- The F Shares will be available for investment between 1 November 2021 and 30 November 2021 (the 'F Class Period'). Following the end of the F Class Period, subject to the Manager's discretion, the Class F Shares will only be available for subsequent issue to existing investors in the Class F Shares and to persons the Manager considers are connected with existing investors in the Class F Shares.
- Any subsequent issue will not be made unless, at the time of issue, the Manager is satisfied on reasonable grounds that the proceeds of the issue can be invested without compromising the Fund's investment objective or adversely affecting its future investment performance; and the issue will not materially prejudice the interests of existing Shareholders, in accordance with COLL 6.2.18R.
- Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### Risk and reward profile



- This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility. As the Fund has less than 5 years price history, this calculation incorporates the volatility of an appropriate benchmark index. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains.
- The Fund has been classed as 5 because its volatility has been measured as above average.

If an investment no longer meets the ethical exclusion criteria it will be sold and the price obtained may be less than could be obtained if a forced sale was not required.
- Charges to Capital Risk: As charges are taken from capital, this will erode capital and may constrain capital growth.

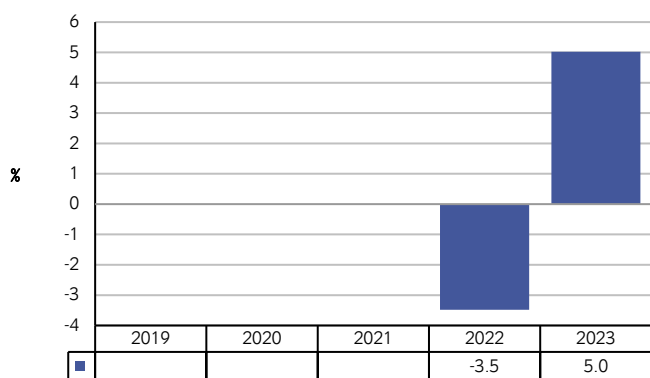
The ongoing charges figure is capped at 0.57% until further notice. If the cap was not in place, the uncapped ongoing charge figure would be 0.71% based on expenses as at 25 June 2024. The ongoing charges are taken from the capital of the Fund. They exclude portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another collective investment undertaking.

You may also be charged a dilution levy (an amount to cover dealing costs incurred by the Fund) on entry to or exit from the Fund. This is normally only charged when the dealing costs are significant.
