

# Key Investor Information Document:

### Objective & Investment Policy

#### Objective

The fund aims to increase the value of the amount you invest in it over a period of years.

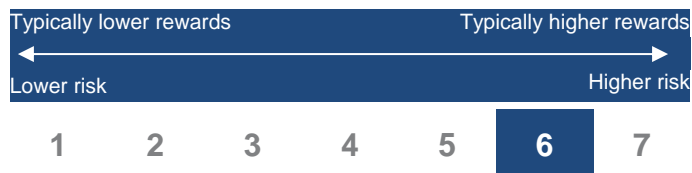
#### Investment Policy

The fund invests primarily in a portfolio of European securities, excluding UK securities, or in the securities issued by companies transacting a significant proportion of their business (at least 50% of revenues) in Europe (excluding the UK).

#### Essential features of the fund:

- The fund intends to invest primarily in companies which pay dividends, but may invest in companies which do not pay dividends.
- The fund may invest in excess of 20% of its Net Asset Value in emerging markets.
- Under normal market conditions the fund intends to invest in at least 20 stocks.
- The fund may invest in securities of companies with a wide range of market capitalizations and in companies domiciled throughout Europe but excluding the UK.
- The bulk of the fund's investments will however be concentrated in liquid shares of companies with a market capitalisation in excess of \$500million, however the fund may invest in liquid shares of companies with a market capitalisation of less than \$500million.
- The fund is considered to be actively managed in reference to the MSCI Europe ex UK Index (the "Benchmark") by virtue of the fact that it uses the Benchmark solely for performance comparison purposes.
- You may sell your investments on any working day in Ireland and the UK.
- Any income the fund receives will be paid out to investors twice a year.
- Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within five years.

### Risk and reward profile



- This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains. The lowest number on the scale does not mean that a fund is risk free.

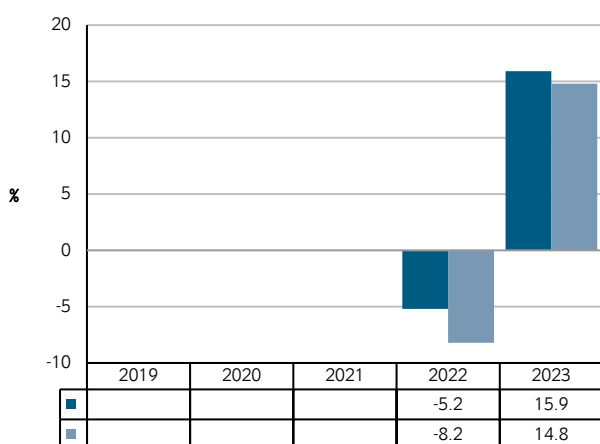
