Objectives and investment policy

Objective: The Fund aims to grow your investment.

Pursuant to the EU Sustainable Finance Disclosure Regulation (EU 2019/2088), this Fund also has sustainable investment as its objective under Article 9.

Policy: The Fund invests at least 70% of its assets in shares of large and mid sized companies in emerging markets or whose business is predominantly based in emerging markets. This includes companies that are listed on exchanges in developed markets.

These companies generally have a total stock market value of at least US\$ 1 billion.

Emerging markets are countries that are progressing toward becoming advanced, usually shown by some development in financial markets, the existence of some form of stock exchange and a regulatory body.

The Fund may invest up to 100% of its assets in emerging markets and any industry.

The Fund will not invest more than 50% of its assets in China A Shares.

The Fund invests at least 90% in shares of high-quality companies which are positioned to contribute to, and benefit from, sustainable development. Investment decisions use a thematic sustainability approach and a quality assessment aiming to identify high quality companies with strong culture, franchise, and resilient financials. All investee companies contribute to positive climate solutions either i) directly or by enabling other companies to contribute to or ii) through their culture, revenue, or expenditure.

Investment Manager will additionally consider whether a company has any harmful or controversial products, services or practices and takes an active approach to engagement and voting. Sustainability decisions are made on information available and may be at risk if underlying information is incorrect or withheld.

The Fund's performance is compared against the value of the MSCI Emerging Markets Index.

The Fund is actively managed meaning that the Fund's manager uses expertise to pick investments rather than tracking a benchmark. A majority of the Fund's assets could be components of the benchmark. Investment of the Fund's assets is not constrained by the benchmark composition and the Fund's manager has complete discretion within the Fund's investment policy to invest in assets without regard to the benchmark.

The Fund may use derivatives with the aim of risk reduction or efficient management.

You can buy and sell shares in the Fund on any dealing day. A dealing day is generally defined as a day on which Irish banks and, if applicable, the relevant stock exchange(s) are open for business. Exceptions are noted on the FSI website. As long as we receive your instruction before 10 am (Irish time) on a dealing day, shares will be bought and sold at that day's price.

The Fund will not pay any income out; instead any income will be reflected in the value of your shares.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within five years.
