### Objective & Investment Policy

#### Objective

The fund aims to increase the value of the amount you invest in it over a period of years.

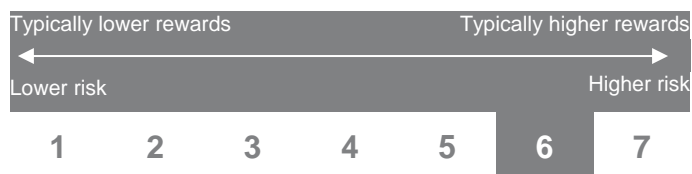
#### Investment Policy

The fund invests in the shares of a range of companies around the world which the Investment Manager deems to be consistently profitable and to meet sustainability criteria.

#### Essential features of the fund:

- Under normal market conditions the fund intends to invest in at least 20 stocks.
- The fund invests in assets in securities of companies with a wide range of market capitalizations and in companies domiciled throughout the world. The majority of the fund's investments will however be concentrated in liquid shares of companies with a market capitalisation in excess of \$500 million, however, the fund may invest in liquid shares of companies with a market capitalisation of less than \$500 million.
- The fund is considered to be actively managed in reference to the MSCI World Index (the "Benchmark") by virtue of the fact that it uses the Benchmark solely for performance comparison purposes.
- You may sell your investment on any working day in Ireland.
- Any income the fund receives will be reinvested to grow the value of your investment.
- Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within five years.

### Risk and reward profile



- This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains. 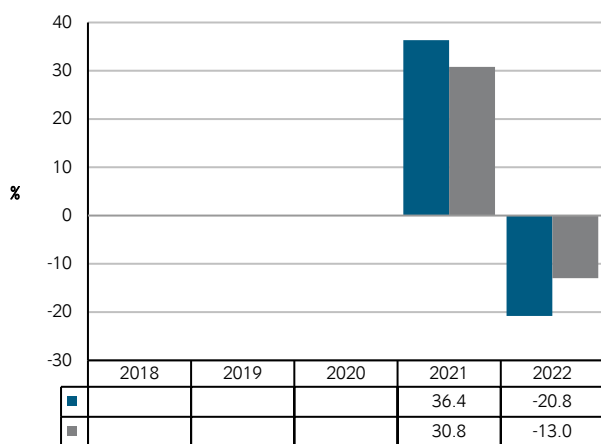
