Investment Policy

The fund invests in the shares of a range of companies around the world which the Investment Manager deems to be consistently profitable and to meet sustainability criteria.

Essential features of the fund:

- Under normal market conditions the fund intends to invest in at least 20 stocks.
- The fund invests in assets in securities of companies with a wide range of market capitalizations and in companies domiciled throughout the world. The majority of the fund's investments will however be concentrated in liquid shares of companies with a market capitalisation in excess of \$500 million, however, the fund may invest in liquid shares of companies with a market capitalisation of less than \$500 million.


