Objectives and investment policy

The aim of the Product is to provide risk-adjusted returns through investments in hard currency denominated debt issued in emerging market countries. The Product invests in a portfolio primarily comprised of debt instruments (i.e. notes, bonds, certificates etc.) issued by public or private issuers in developing countries (emerging markets) and denominated in currencies of countries, which are members of the OECD (Organisation for Economic Cooperation and Development). The Investment Manager invests in countries where the Investment Manager is able to assess specific political and ESG risks. Issuers are located in emerging market countries in South and Central America (including the Caribbean), Central and Eastern Europe, Asia, Africa and the Middle East. Furthermore, the Product enters into emerging market currency forward contracts (a currency market transaction in which a seller agrees to deliver a specific currency to a buyer at some point in the future). The Product can also take long and short positions in markets, securities and groups of securities through derivative contracts and may invest up to 10% of its net assets in contingent convertible securities (CoCos). The Product may invest in debt securities of any maturity or credit rating and may invest in high yield debt securities. The Product may invest up to 10% of its net assets in distressed or defaulted debt securities. The Investment Manager seeks to integrate material environmental, social and governance (ESG) factors within its investment process.

The Product's performance is measured against the benchmark, the JPMorgan Emerging Markets Bond Index (EMBI) Global Diversified. The Product is actively managed within its objective and is not constrained by a benchmark.

This Product promotes environmental and/or social characteristics within the meaning of Article 8 of SFDR.

Any income generated by the Product is reinvested to grow the value of your investment.

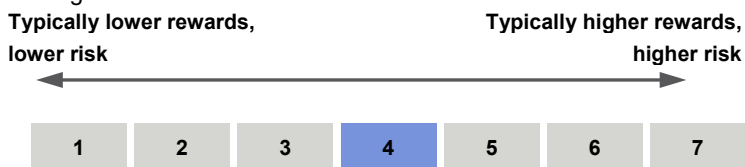
The Product is not suitable for investors who plan to withdraw their money within 5 years. Investors should consider the Product only for the more aggressive portion of their portfolio. In addition, the Product is intended for investors who can accept the risks entailed in investing in securities of emerging market countries. The Product is suitable for investors who: Seek a return over the long term; Seek income whether in the form of capital appreciation or distributions, as outlined in the "Dividend Policy" section of the prospectus; Accept the risks associated with this type of investment, as set out in the "Risk Factors" section of the prospectus.

You can buy and sell shares in the Product on a daily basis on any full working day in Luxembourg and when the New York Stock Exchange is open for trading.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



- This Fund is categorized as a 4 because funds of this type have historically experienced moderate rises and falls in value. However, even the lowest category does not mean "risk free". - Financial techniques / derivatives: The fund may use financial derivative instruments as part of the investment process. There is no guarantee that they will deliver the expected results.
- Credit and counterparty risk: Issuers of the securities or other instruments in which the Fund invests may be subject to credit difficulties leading to the loss of some or all of the sums invested in such securities or instruments or payments due on such securities or instruments. The Fund may also be

exposed to credit risk in relation to the financing counterparties with whom the Fund trades or places margin or collateral in respect of transactions in derivative instruments and may bear the risk of counterparty default.

- Liquidity risk: Liquidity risk exists when a particular instrument is difficult to purchase or sell. Investments that trade less can be more difficult or more costly to buy, or to sell, than more liquid or active investments. It may not be possible to sell or otherwise dispose of illiquid securities both at the price and within a time period deemed desirable by the Fund.
- Debt securities risk: Debt securities are affected by changes in interest rates and credit quality. The Fund will be more sensitive to interest rates depending on the average maturity or average duration of its portfolio. Below investment grade securities and distressed or defaulted debt are more sensitive to these risks.
- CoCos risk: CoCos are relatively complex instruments and may be subject to additional risks, including credit and counterparty risk, liquidity risk and debt securities risk. The Fund also is exposed to the risk that the issuer of the debt security or preferred stock portion of a CoCo may fail to meet its obligations, as well as the performance associated risks of the underlying common stock into which it can be converted.
- Emerging markets risk: Emerging markets or less developed countries may face more political, economic or structural challenges than developed countries. This may mean your money is at greater risk.
- All the risks currently identified as being applicable to the Fund are detailed in the prospectus.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

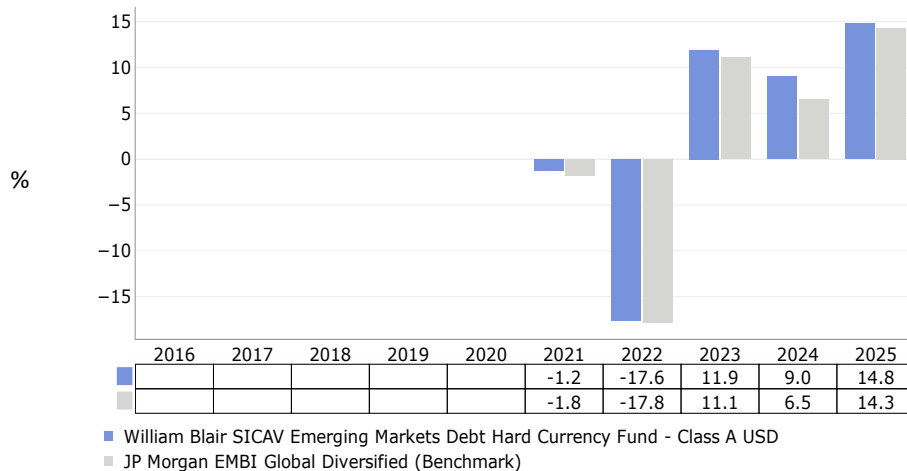
