## WHAT IS THE PRODUCT?

**Type:** This product is an open-ended, non-interest bearing, secured, limited recourse debt security of the Issuer, that is fully secured by holdings of Internet Computer or other assets denominated therein. This product's primary listing is Börse Frankfurt but it may be listed on additional exchanges and MTFs. Typically, such products are known as exchange traded products (ETPs).

**Term:** This product is not subject to any fixed term.

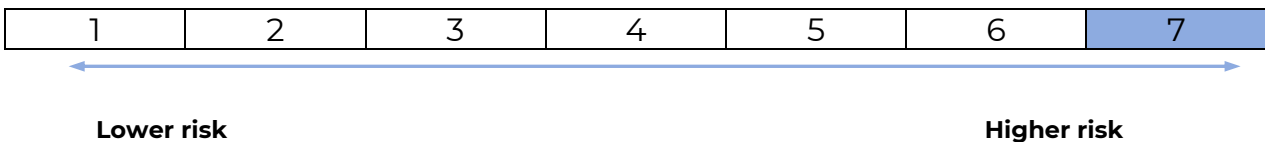
**Objectives:** TValour Internet Computer Physical Staking ETP provides investors with exposure to the performance of Internet Computer (ICP) token. Investors are expected to purchase and sell the securities in the secondary markets on the stock exchanges or MTFs where the securities are listed during the relevant exchange opening hours. Price data (in USD) from Vinter is used to calculate the price of the reference asset. The securities are only issued directly to authorised participants (who are generally regulated financial institutions) in return for delivery of the underlying asset(s) which must be newly minted or sourced from a defined list of crypto currency exchanges. All assets relating to the securities are secured by way of a pledge to a collateral agent acting on behalf of investors.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk indicator



**The risk indicator assumes you keep the product for the recommended holding period of at least 1 Year. The actual risk can vary significantly if you cash in at an early stage and you may get back less. To the extent that the currency of the country in which you purchase this product, or the account currency differs from the product currency, please be aware of currency risk. If you buy and trade this product in a different currency, the final return you get depends on the exchange rate between the two currencies. **This risk is not considered in the indicator shown above.**
