WHAT IS THIS PRODUCT?

Туре:	An umbrella fund constituted as a unit trust established pursuant to the Unit Trusts Act, 1990.	
Term:	The Fund does not have a targeted closure date and may be liquidated at any time, as further detailed in the Prospectus	
Objectives:	To provide long-term capital growth by investing in shares of Latin American companies.	
	Investment Policy: The Fund invests at least 70% of its total assets (excluding cash and cash-equivalent assets) in securities of companies incorporated in, or which are expected to have a significant proportion of their assets or other interests in Latin America, or which carry on their principal business in or from Latin America. There is no limit to the amount which may be invested in any one country.	
	The Fund is also permitted to invest to a lesser extent in fixed income instruments and cash on deposit. The base currency of the Fund is USD.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The actual risk can vary significantly if you cash in at an early stage and you may get back less than your initial investment. You may have to pay significant extra costs to cash in early. WHAT HAPPENS IF BARING INTERNATIONAL FUND MANAGERS (IRELAND) LIMITED IS UNABLE TO PAY OUT?

The assets of the Fund are segregated from those of Baring International Fund Managers (Ireland) Limited. The Depositary is responsible for the safekeeping of the Fund's assets. To that effect, if Baring International Fund Managers (Ireland) Limited defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk of the Fund suffering some loss in case of default of the Depositary. You may face a financial loss if your broker or the entity from whom you purchased the Fund was to default. As an investor in the Fund, there is no compensation or guarantee scheme in place.
