The Company and the Manager are authorised in Ireland and regulated by the Central Bank of Ireland (the "CBI"). The CBI is responsible for supervising the Manager in relation to this Key Information Document.

WHAT IS THIS PRODUCT?

Type: Shares in a Variable Capital Company authorised as a UCITS

Term: This product is not subject to any fixed term. The board of the Company may terminate the product unilaterally in the circumstances set out in the prospectus.

Objective: The Fund aims to grow your investment. Pursuant to the EU Sustainable Finance Disclosure Regulation (EU 2019/2088), this Fund also has sustainable investment as its objective under Article 9.

Policy: The Fund invests at least 70% of its assets in shares of large and mid-sized companies based in or having significant operations in the Asia Pacific region (excluding Japan) that are listed on exchanges worldwide. These companies generally have a total stock market value of at least US\$1 billion. The Fund may invest up to 100% of its assets in markets in the Asia Pacific region and in any industry. The Fund will not invest more than 50% of its assets in China A Shares. The Fund invests at least 90% in shares of high-quality companies which are positioned to contribute to, and benefit from, sustainable development. Investment decisions use a thematic sustainability approach and a quality assessment aiming to identify high quality companies with strong culture, franchise, and resilient financials. All investee companies contribute to improving human development, while many also contribute to positive climate solutions either i) directly or by enabling other companies to contribute to or ii) through their culture, revenue, or expenditure. The Investment Manager will additionally consider whether a company has any harmful or controversial products, services or practices and takes an active approach to engagement and voting. Sustainability decisions are made on information available and may be at risk if underlying information is incorrect or withheld. The Fund's performance is compared against the value of the MSCI AC Asia Pacific ex Japan Index. The Fund is actively managed meaning that the Investment Manager uses expertise to pick investments rather than tracking a benchmark. A majority of the Fund's assets could be components of the benchmark. Investment of the Fund's assets is not constrained by the benchmark composition and the Investment Manager has discretion within the Fund's investment policy to invest in assets without regard to the benchmark.

The Fund may use derivatives to reduce risk or to manage the Fund more efficiently. 5 years has been chosen as the Fund should be considered as a long term investment given its objective. You can buy and sell shares in the Fund on any dealing day. A dealing day is generally defined as a day on which Irish banks and, if applicable, the relevant stock exchange(s) are open for business. Exceptions are noted on the FSI website. As long as we receive your instruction before 10 am (Irish time) on a dealing day, shares will be bought and sold at that day's price. You may receive less than expected if you sell your shares earlier than the recommended holding period. You may receive a regular income from your investment which will be paid semi-annually. This may affect the potential growth of your investment.

Intended retail investor: This product is compatible with retail investors who are seeking growth over the long term and who have a basic level of knowledge and/or experience and are able to bear the loss of their investment.

This document describes the Fund, which is a sub-fund of the Company. The Company is an umbrella fund authorised as a UCITS with multiple sub-funds and segregated liability between them under Irish law, which seeks to prevent cross liability between sub-funds. The Company appointed the Manager as its UCITS management company. Investors may request but do not have an automatic right to exchange an investment in the Fund for an investment in another class of the Fund or sub-fund of the Company. The depositary of the Company is HSBC Continental Europe Ltd. The prospectus, and annual and semi-annual reports contain information about all of the sub-funds and share classes of the Company and are available free of charge in English, (the prospectus is also available in German and Swiss German) at firstsentierinvestors.com or by contacting the Management Company, the Administrator or IFS Investor Services Team. You can also obtain any of these documents through the relevant facility provided by the Manager or the representative in your country as disclosed generally, or in the relevant prospectus country supplement available, at firstsentierinvestors.com. Whilst the Company has exercised its UCITS marketing passport rights in certain countries, please note that not all sub-funds and share classes may be registered for distribution in your jurisdiction. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. Please note that even investments in the lowest risk class can lose money and that in extremely adverse market conditions investors should be willing to accept severe losses. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator ("SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the fund to pay you. **Be aware of currency risk. WHAT HAPPENS IF FIRST SENTIER INVESTORS (IRELAND) LIMITED IS UNABLE TO PAY OUT?

You could lose some or all of your investment due to a default of the Fund, the Company's or the Manager's appointed service providers. The Fund's investments are held by the Depositary or a third party custodian for safekeeping, which means that in case of a default or a loss of financial instrument belonging to the Fund which is not recoverable, you might not be able to get back the current value of your investment. The Company is also an umbrella fund with segregated liability and, under Irish law, there generally will not be the potential for cross liability between the Funds. Notwithstanding the foregoing, there can be no assurance that, should an action be brought against the Company or the Fund in the courts of another jurisdiction, the segregated nature of the Funds would necessarily be upheld. A default by the Fund, the Company's or the Manager's appointed service providers would not be covered by an investor compensation scheme in Ireland.

WHAT ARE THE COSTS?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario. Please be aware that these are only assumptions for the purposes of illustrating the costs.

- USD 10,000 is invested.
