You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is a distributing share class of the Fund denominated in EUR.

The UCITS is an open-ended investment company with variable capital and qualifies as an undertaking for collective investment in transferable securities, subject to Directive 2009/65/EC of the European Parliament and of the Council of 13 July 2009 as amended from time to time.

As an investment fund, the return of the Fund depends on the performance of its underlying assets.

Term

The Fund does not have a fixed maturity. All the shares in the Fund may be redeemed by the board of directors of the UCITS or at a general meeting of shareholders in certain circumstances details of which are outlined in the prospectus. As such, the UCITS Management Company may not unilaterally terminate the Fund.

Objective

Investment Objective:

To provide liquidity and an attractive rate of income relative to short term interest rates, to the extent consistent with the preservation of capital.

Short term money market securities (e.g. commerical paper and certificates of deposit) and reverse repurchase agreements.

The debt securities will be listed or traded on a Regulated Market or an Other Regulated Market.

Investment Policy:

This is a Short-Term LVNAV Money Market Fund that will invest in a range of high quality, short term (investments will have no more than 397 days or less until the amount is fully repaid) fixed and floating interest rate securities, government and corporate bonds and asset-backed securities denominated in Euro. The Fund may also enter into reverse repurchase agreements, for efficient portfolio management purposes, to buy securities from other financial institutions for cash with an associated agreement to resell them at a later date.

The Fund includes certain tobacco, gambling, weapons-related and fossil fuel-related exclusions. Further details are contained in the MSLF prospectus.

The Fund may invest up to 20% of its investment in ancilliary liquid assets i.e. bank deposits.

The Fund is actively managed and the management of the Fund is not constrained by or compared to a benchmark

Other Information:

It is expected that the share price of the distributing share classes will remain at EUR 1 through the distribution of dividends or sale of shares.

Redemption and Dealing: Investors may buy and sell shares on any day which is not designated as a TARGET closing day by the European Central Bank

Distribution Policy: Income from the Fund may be paid out to you in cash or additional shares.

- Seek a return over the short term
- Seek to invest in a liquidity fund
- Seek liquidity from their investments

What are the risks and what could I get in return?

Risk indicator





The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 1 out of 7, which is the lowest risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact the capacity to pay you.

Performance scenarios

What happens if MSIM Fund Management (Ireland) Limited is unable to pay out?

The assets of the Fund are held in safekeeping by the Depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. In the event of the Depositary's insolvency, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent as the Depositary is required by law and regulation to segregate its own assets from those of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from its negligence, fraud or intentional failure to fulfill its obligations. Such loss is not covered by an investors compensation or protection scheme.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 1 year

This product is designed for short term investments; you should be prepared to stay invested for at least 1 year. However, you can redeem your investment without penalty incurred for disinvestment prior to the end of the recommended holding period, or hold the investment longer. Redemptions must be received by the registrar and transfer agent no later than 1pm GMT to be dealt with on the basis of the net asset value per share applicable on that valuation date. Redemptions received by the registrar and transfer agent after that cut-off time will be dealt with on the next valuation date. Redemptions may be made in a number of shares. Redemption payments will be affected one (1) Bank business days, which are also days when the relevant foreign exchange market is open, after the redemption of the shares. Any cashing-in before the end of the recommended holding period may have a negative consequence on your investment.
