## What is this product?

### Objectives:

Global ESG socially responsible active investment strategy seeking to generate favorable risk-adjusted returns through current income by diversified investment in US and non-US dollar high yield corporate bonds with average expected maturity of five years or less.

The fund will comprise a diversified portfolio of global High Yield corporate bonds denominated in Hard Currencies and predominantly issued in the United States, EU markets or in other member countries of the OECD with an average expected life to maturity of approximately five years or less, although the Investment Manager shall have discretion to vary the average expected life from time to time if warranted by market conditions.

A Shareholder may redeem its shares in the Fund on demand, on each day on which banks in Luxembourg and New York are open all day for business. The fund is actively managed and invests predominantly in corporate bonds rated below investment grade.

This Fund is not managed with reference to a benchmark.

### Intended Retail Investor:

This Sub-Fund is appropriate for all investors with a basic knowledge of the capital markets who, as a core or component of a portfolio of investments, may prefer a socially responsible investment fund that seeks to generate current income while also experiencing lower volatility than the broader high yield market by investing in diversified portfolio of high yield debt securities denominated in Hard Currencies with a short-term investment horizon of generally less than five years and issued by companies domiciled or listed in the US, EU or other member countries of the OECD.

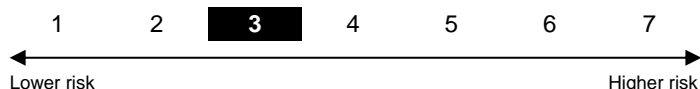

### Risk indicator
