## What is this product?

**Type:** This product is a UCITS Fund authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier.

**Term:** This product is not subject to any fixed term.

### Objectives:

**Objectives and Investment Policy** This product aims to achieve total returns from a combination of capital appreciation and income generation by primarily investing in a diversified portfolio of fixed income securities issued by governments, agencies, supra-nationals and corporate issuers in Asia. The Sub-Fund invests at least 70% of its net assets in a diversified portfolio of fixed income securities, issued by governments, agencies, supra-nationals and corporate issuers in Asia. The fund may invest up to 30% of its net assets in RMB-denominated debt securities that are circulated in the China Interbank Bond Market via Bond Connect and up to 30% of its net assets in cash and fixed income securities outside Asia. The fund may invest more than 30% in issuers located in the PRC, up to 40% in high yielding debt securities, and up to 20% in debt instruments with loss absorption features including convertible securities. The fund may also invest indirectly through specialist financial techniques (known as derivatives). The fund may use derivatives for hedging and efficient portfolio management but not for leverage as an investment strategy. Nevertheless, although expected to be limited, the use of derivatives may introduce constant leverage to the fund in order to hedge currency exposure or for risk management. The level of leverage may vary depending on the exposure to non-base currency and the risk appetite of the portfolio manager. The fund's leverage will not exceed 100% of the fund's Net Asset Value, as measured using the commitment approach.

**Fund Benchmark** The fund employs an actively managed investment strategy. The fund uses the 50% JP Morgan Emerging Local Markets Index + 50% JP Morgan Asia Credit TR USD Index as a benchmark for performance comparison purposes only.

**Dealing Frequency** You may buy and sell shares on any day on which banks in Luxembourg are open for business other than (i) any day on which any exchange or market on which a substantial portion of the fund's investments is traded in accordance with the fund's investment objective and policy is closed, or (ii) such other day(s) as the directors of Manulife Global Fund may determine. The fund holiday calendar is available on the website noted above.

**Distribution Policy** This share class does not pay out a distribution. Any investment income generated will be reinvested.

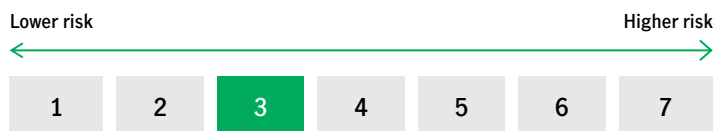

### Intended Retail Investor:

This product is designed to be purchased with advice and should form part of a broader portfolio of investments. The product is suitable for investors including those with a basic knowledge of financial instruments, who are comfortable with the level of risk in the risk indicator section. Investors must be able to bear capital loss and should have an investment time horizon of at least five years.

## What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the ability for you to receive a positive return on your investment.

**Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**

## Performance scenarios

The figures shown in the table below and in the latest performance scenarios include all the costs of the product itself but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back. What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of this share class (where the class has been in existence under 10 years, supplemented by the performance of another class of the fund with an earlier inception date, if appropriate, and further, by the share class benchmark where necessary to complete a period of 10 years). The stress scenario shows what you might get back in extreme market circumstances.

The unfavourable scenario occurred for an investment between 11/2017 and 10/2022, the moderate scenario occurred for an investment between 05/2020 and 04/2025, and the favourable scenario occurred for an investment between 01/2016 and 12/2020.

### What happens if Manulife Investment Management (Ireland) Limited is unable to pay out?

The Management Company has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

### What are the costs?

#### Costs over time

**How long should I hold it and can I take money out early?**

**Recommended holding period: 5 years**

This product has no required minimum holding period but is designed for medium to long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type. The minimum recommended holding period is therefore 5 years. You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the fund on any business day (as set out in the fund's prospectus).
