What is this product?

Type: This product is a UCITS Fund authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier.

Term: This product is not subject to any fixed term.

Objectives:

Objectives and Investment Policy This product aims to achieve long-term capital growth by investing primarily in equity and equity-related securities of companies who are leaders in making positive contributions to climate change ("Climate Leaders"). Companies deriving more than 25% of revenue from fossil fuel generation, more than 5% from alcohol, tobacco, adult entertainment, gambling operations, conventional weapons and any revenue from controversial weapon, oil and gas extraction and production and thermal coal mining and sales are automatically eliminated from investment consideration (exclusion framework). The fund may hold up to 20% in cash and cash equivalents, and/or equity and equity-related securities of companies that do not satisfy the definition of Climate Leaders but undertake economic activities that contribute to the environmental objective of the fund through key resource efficiency requirements which will result in lowering either Green House Gas (GHG) emission intensity, water and/or waste intensity. The fund may also invest indirectly through specialist financial techniques (known as derivatives). The fund may use derivatives for hedging and efficient portfolio management but not for leverage as an investment strategy. Nevertheless, although expected to be limited, the use of derivatives may introduce constant leverage to the fund in order to hedge currency exposure or for risk management. The level of leverage may vary depending on the exposure to non-base currency and the risk appetite of the portfolio manager. The fund's leverage will not exceed 100% of the fund's Net Asset Value, as measured using the commitment approach.

Fund Benchmark The fund employs an actively managed investment strategy. The fund uses the MSCI World Index NR USD Index as a benchmark for performance

comparison purposes only and does not track the performance of the benchmark, but is managed in reference to a benchmark.

Dealing Frequency You may buy and sell shares on any day on which banks in Luxembourg are open for business other than (i) any day on which any exchange or market on which a substantial portion of the fund's investments is traded in accordance with the fund's investment objective and policy is closed, or (ii) such other day(s) as the directors of Manulife Global Fund may determine. The fund holiday calendar is available on the website.

Distribution Policy This share class does not pay out a distribution. Any investment income generated will be reinvested.

This product is designed to be purchased with advice and should form part of a broader portfolio of investments. The product is suitable for investors including those with a basic knowledge of financial instruments, who are comfortable with the level of risk in the risk indicator section. Investors must be able to bear capital loss and should have an investment time horizon of at least five years. The product is suitable for investors with sustainability preferences and falls within the scope of article 9 of SFDR.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the value of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance scenarios

What happens if Manulife Investment Management (Ireland) Limited is unable to pay out?

The fund does not include any protection from future market performance, so you could lose some or all of your investment. These losses may be covered by the Irish Investor Compensation Company DAC, subject to certain limitations. However, your investments are deposited with a third-party custodian bank, which means that in case of default of Manulife Investment Management (Ireland) Limited, you should be able to get back the current value of your investment.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for medium to long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type. The minimum recommended holding period is therefore 5 years. You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the fund on any business day (as set out in the fund's prospectus).
