MSIM Fund Management (Ireland) Limited is appointed as the UCITS Management Company of the Fund and is authorised by the Central Bank of Ireland. MSIM Fund Management Ireland is a member of Morgan Stanley, a global financial group.

## What is this product?

### Type

This product is an Acc share class of the Fund denominated in USD.

The UCITS is an open-ended investment company with variable capital and qualifies as an undertaking for collective investments in transferable securities, subject to Directive 2009/65/EC of the European Parliament and of the Council of 13 July 2009 as amended from time to time.

As an investment fund, the return of the Fund depends on the performance of its underlying assets.

### Term

The Fund and share class were incorporated for an undefined period. The manufacturer may not terminate this product unilaterally. Only the board of directors of the UCITS or a general meeting of shareholders may decide to terminate this product.

### Objective

#### Investment Objective:

Long term growth of your investment involving economic activities that address global and environmental or societal challenges, whilst taking into account the long term carbon reduction objectives of the Paris Agreement.

The Fund is in scope of Article 9 of the European Sustainable Finance Disclosure Regulation.

#### Main Investments:

At least 70% of the Fund's investments will be in company shares, including depositary receipts.

#### Investment Policy:

To invest mainly in companies, based in developed European markets determined by the classification of the MSCI Europe Net Index ("Benchmark"), and considered as leaders in the business of addressing global, environmental and societal challenges such as environmental sustainability and resource efficiency, diversity, equity and inclusion, respect for human rights, product responsibility, human capital management, accountable governance and transparent operations.

The Fund will maintain a carbon profile that follows the net zero objectives of the Paris Agreement, as reflected in the appropriate Paris-Aligned benchmark, or in the absence of an approved Paris-Aligned benchmark, the Fund will maintain a substantially lower carbon footprint, in the range of 50% than that of the Benchmark and taking into account the long-term carbon reduction objectives of the Paris Agreement.

The Fund will seek to maintain higher levels of diversity at a portfolio level than the Benchmark as measured by weighted average number of women at board level. The aforementioned ESG criteria will result in a 20% or more reduction of the investment universe, and the Investment Adviser will aim to ensure that at least 90% of the issuers in the portfolio are assessed against these ESG considerations.

The Fund includes weapons-related exclusions alongside other sector/industry restrictions, including alcohol, tobacco; and companies involved with severe ESG controversies without material remediation and improvement. #### Other Information:

The Fund may invest up to 30% of its assets in companies which do not meet the above criteria, provided such securities meet the Investment Adviser's ESG criteria.

The Fund measures its performance and gender diversity level against the Benchmark and its carbon footprint against either the Benchmark or the appropriate Paris-aligned benchmark.

The Fund also references the Benchmark for the purpose of defining the countries it will invest into. The Fund is actively managed and is not designed to track the Benchmark. Therefore, the management of the Fund is not constrained by the composition of the Benchmark.

The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets, for investment or efficient portfolio management purposes. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ("Financial Derivative Instruments" section) for more details.

This is a currency hedged share class. It aims to reduce the impact on your investment of movements in the exchange rate between the fund currency and the share class currency.

**Redemption and Dealing:** Investors may buy and sell shares on every full banking business day in Luxembourg.

**Distribution Policy:** Income generated by the Fund is reinvested and included in the value of shares.

### Intended retail investor

The Fund is not suitable for investors who plan to withdraw their money within 3 years.

## What happens if MSIM Fund Management (Ireland) Limited is unable to pay out?

The assets of the Fund are held in safekeeping by the Depositary. ## What are the costs?

### Costs over time

## How long should I hold it and can I take money out early?

### Recommended minimum holding period: 3 years

This product is designed for medium-long term investments; you should be prepared to stay invested for at least 3 years. However, you can redeem your investment without penalty incurred for disinvestment prior to the end of the recommended holding period, or hold the investment longer. Redemptions must be received by the registrar and transfer agent no later than 1pm CET to be dealt with on the basis of the net asset value per share applicable on that valuation date. Redemptions received by the registrar and transfer agent after that cut-off time will be dealt with on the next valuation date. Redemptions may be made in a number of shares. Redemption payments will be affected three (3) Bank business days, which are also days when the relevant foreign exchange market is open, after the redemption of the shares. Any cashing-in before the end of the recommended holding period may have a negative consequence on your investment.
