The Fund and the PRIIPs are registered in Luxembourg and supervised by the Commission de Surveillance du Secteur Financier.

What is this product?

This product is an accumulating share class of the Fund denominated in GBP.

The UCITS is an open-ended investment company with variable capital and qualifies as an undertaking for collective investments in transferable securities, subject to Directive 2009/65/EC of the European Parliament and of the Council of 13 July 2009 as amended from time to time

As an investment fund, the return of the Fund depends on the performance of its underlying assets.

Term

The Fund does not have a fixed maturity. All the shares in the Fund may be redeemed by the board of directors of the UCITS or at a general meeting of shareholders in certain circumstances details of which are outlined in the prospectus. As such, the UCITS Management Company may not unilaterally terminate the Fund

Objective

Investment Objective:

To generate total return, being income plus capital appreciation

Main Investments

At least 70% of the Fund's investments will be in fixed income securities (e.g. bonds), through long and short investment exposures to emerging market debt Investment Policy

To invest in (i) fixed income securities issued by corporations and governmental or governmental related issuers located in emerging markets; and/or (ii) derivative instruments denominated in or based on the currencies, interest rates, or issuers of emerging market issuers. Emerging market shall be any country determined by the Investment Adviser to have an emerging market economy, considering factors such as the country's political and economic stability and the development of its financial and capital markets and includes frontier market countries. The Fund will not have a specific industry or sector focus, and may invest in instruments of any credit rating, including those rated below investment grade (rated below BBB by either Standard & Poor's Ratings Services or Fitch Ratings, or below Baa by Moody's Investors Service, Inc.).

As an essential and integrated part of the research process and through engagement with issuers, the Investment adviser incorporates an assessment of sustainability-related risks and opportunities into the assessment process.

The Fund includes tobacco, climate- and weapons-related exclusions and does not invest in sovereign issuers from countries with significant social violations. The Fund will measure its performance against the JP Morgan Emerging Markets Bond (JEMB) Hard Currency/Local Currency 50-50 Index (the "Benchmark"). The Fund is actively managed and references the Benchmark for the purpose of setting a geographical allocation of the countries the Fund will invest into. While the Fund will generally hold assets that are exposed to the Benchmark, it can invest in such components in different proportions to the country allocations, and it can hold assets which are not exposed to the Benchmark. Hence, there are no restrictions on the extent to which the Fund's performance may deviate from the Benchmark.

Other Information

The Fund may invest up to 30% of its assets in other fixed income securities that do not meet the above criteria, for example fixed income securities which are not exposed to emerging markets.

The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets, for investment or efficient portfolio management purposes. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Financial Derivative Instruments' section) for more details.

Redemption and Dealing: Investors may buy and sell shares on every full banking business day in Luxembourg.

Distribution Policy: Income generated by the Sub-Fund is reinvested and included in the value of shares.


Further Information:

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years.



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity to pay you.

Be aware of currency risk. The currency of this share class may be different from that of your country, as you may receive payments in the currency of this share class and not that of your country, the final return will depend on the exchange rate between these two currencies.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your adviser or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average and best performance of the product over the last 10 years, by identifying, depending on the performance scenarios and as defined in the Key Information Document's EU regulation, all overlapping sub-intervals individually (i) equal in length to the recommended holding period which start or end in each month which are contained within that period of 10 years or (ii) equal or shorter in length to the recommended holding period, but equal to or longer than one year, which end at the end of that period of 10 years. For any Fund with less than 10 years of historical data, an appropriate proxy benchmark has been applied for performance scenario calculations. These calculations are net of all applicable costs.

What happens if MSIM Fund Management (Ireland) Limited is unable to pay out?

The assets of the Fund are held in safekeeping by the Depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. In the event of the Depositary's insolvency, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent as the Depositary is required by law and regulation to segregate its own assets from those of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from its negligence, fraud or intentional failure to fulfill its obligations. Such loss is not covered by an investors compensation or protection scheme.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product performs. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed (i) in the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario and (ii) GBP 10,000 is invested.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 years

This product is designed for medium-long term investments; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty incurred for disinvestment prior to the end of the recommended holding period, or hold the investment longer. Redemptions must be received by the registrar and transfer agent no later than 1pm CET to be dealt with on the basis of the net asset value per share applicable on that valuation date. Redemptions received by the registrar and transfer agent after that cut-off time will be dealt with on the next valuation date. Redemptions may be made in a number of shares. Redemption payments will be affected three (3) Bank business days, which are also days when the relevant foreign exchange market is open, after the redemption of the shares. Any cashing-in before the end of the recommended holding period may have a negative consequence on your investment.
